### ORDER

As per the paper read as (1) above Government have sanctioned Rs.1,00,00,000/-(One Crore only) to the eligible students of the Engineering colleges under Cooperative Academy of Professional Education(CAPE) in accordance with the Cooperative Professional Education Fund Scheme, 2015.

2) As per the paper read as (2) above Government have accorded sanction to award Rs.15,000/- each to the eligible students of the Engineering colleges under CAPE and approved the terms of disbursement.

3) As per the letter read as (4) above the Director CAPE has reported that only 4 out of 48 sanctioned seats were filled up which was reserved for the children of employees working in the Co-operative Sector / Institution during the academic year 2021-22. In order to increase the number of admissions to this category the 179th Executive Committee of CAPE, as per the paper read as (3) above, had resolved to increase the E K Nayanar Professional Education scholarship being awarded to the wards of staff members and members of the administrative bodies of Cooperative societies/Banks/institutions

registered under Kerala Cooperative Societies Act, 1969 from Rs. 15,000/- to Rs.30,000/-. The Director CAPE, as per the letter read as (4) above has requested Government to increase the scholarship amount as per the resolution of the Executive Committee in accordance with the Cooperative Professional Education Fund Scheme, 2015.

4) Government have examined the matter in detail and are pleased to accord sanction to increase the E K Nayanar Professional Education scholarship being awarded to the wards of staff members and members of the administrative bodies of Cooperative Societies/Banks/Institutions registered under Kerala Cooperative Societies Act, 1969 from Rs. 15,000/- to Rs.30,000/- in accordance with the Cooperative Professional Education Fund Scheme, 2015.
